

**FINANCE RESOLUTIONS**  
**B.C. REGIONAL CONVENTION - 2008**

**RESOLUTION # F-1**

**Affiliation to Labour Councils: BC PSAC Regional Council**

**WHEREAS** CLC District Labour Councils are the house of labour and strong supporters of social and economic justice within our communities;

**AND WHEREAS** affiliation to District Labour Councils provides our members with a strong voice to promote their issues;

**AND WHEREAS** the PSAC encourages Area Councils to promote local affiliation with District Labour Councils; (Section 14, Sub-Section 5).

**AND WHEREAS** the cost of affiliating to District Labour Councils is prohibitive for many locals;

**THEREFORE BE IT RESOLVED** that the PSAC reimburse locals that affiliate to a District Labour Council 50% of the annual cost of affiliating to their District Labour Council.

**RESOLUTION # F-2**

**WHEREAS**, the BC PSAC is affiliated to the CLC and labour councils are composed of locals that are affiliated to the CLC;

**WHEREAS**, participation on labour councils is vital as they are the voice and organization of the labour movement at the community level; participate in national action campaigns; assist unions on strike; organize political action; and develop international solidarity and to work for social justice in the community;

**WHEREAS**, the BC PSAC Area Councils realize that affiliation with their District Labour Councils is beneficial to its members, they have very limited funding to support locals to affiliate;

**THEREFORE BE IT RESOLVED** that the PSAC support local involvement in District Labour Councils and reimburse 50% of the dues charged by the District Labour Councils to any locals wanting to affiliate.
